

APPENDIX I

FAOBMB SCHEDULE OF FEES AND MONETARY VALUES

1 January 2020 - 31 December 2020

(Ratified by Council on 19 August 2020)

Monetary sums are expressed in United States dollars (\$ USD)

Membership fees

The subscription rate for each constituent member Society depends on the Group and Subgroup into which the national Society is classified. Three Groups A, B, C and five Subgroups 1, 2, 3, 4 and 5 are classified according to their economic status and number of members within a specified range, respectively. Annual rates are notionally set in terms of Units and the subscription for each Group and Subgroup combination is in accordance with Units being subjected to a specified multiplier for each combination.

Notes to Schedule 1:

The classification of the economic status of Countries is according to the World Bank listing of 2018.

Group A includes low and lower-middle income countries, Group B includes upper-middle income countries, Group C includes high income countries, each as specified in the official World Bank List of Economies.

Subgroup 1 includes Societies with no more than 100 members; Subgroup 2 includes Societies with more than 100 members but no more than 500 members; Subgroup 3 includes Societies with more than 500 members but no more than 1,000 members; Subgroup 4 includes Societies with more than 1,000 members but no more than 5,000 members; Subgroup 5 includes Societies with more than 5,000 members.

For the payment of annual subscription fees by individual constituent member Societies, One Unit has the specified value of \$180. [Confirmed by Council, August 2019].

Notes to Schedule 2:

The annual subscription fee payable by each Society shall be a sum in United States dollars computed according to a conversion factor to be determined by Council from time to time that assigns a particular value for each Unit expressed in United States dollars.

One Unit has the specified value of \$180. The rate for all combinations is the exact product of the values in Schedule 1 by the conversion factor, except for Group A/Subgroup 1 that is rounded down to \$140.
